Terms and Conditions – L.M.J. Geboortegeluk

These terms and conditions apply to all services offered by L.M.J. Geboortegeluk, based in Someren, The Netherlands, including:

- Birth preparation courses (group and private)
- Pregnancy massages
- Postpartum treatments
- Other guidance and support services

1. Booking and payment

A booking is confirmed once full payment has been received.

An invoice will be sent by email after booking. Payment must be completed within 14 days of the invoice date and always prior to the scheduled appointment or course date.

If payment is not received on time, L.M.J. Geboortegeluk reserves the right to cancel the reservation.

Payment in instalments is only possible if agreed in writing in advance.

2. Cancellation and rescheduling

Cancellation or refund after payment is not possible.

If the booked date proves to be inconvenient, the appointment or course may be rescheduled, subject to availability.

For individual appointments (such as pregnancy and postpartum massages), rescheduling is possible up to 24 hours prior to the appointment.

3. Medical circumstances

In case of medical circumstances that make participation impossible, such as hospitalization, early birth, or pregnancy-related complications, a suitable solution will be discussed, such as rescheduling or an alternative option.

L.M.J. Geboortegeluk may request a written confirmation from a midwife, doctor, or therapist.



4. Cancellation or changes by L.M.J. Geboortegeluk

L.M.J. Geboortegeluk reserves the right to reschedule or cancel an appointment, treatment, or course in case of illness, force majeure, or unforeseen circumstances.

In such cases, an alternative date or suitable solution will be offered. If no suitable alternative can be agreed upon, the paid amount will be refunded.

5. Participation and personal responsibility

Participation in courses, massages, and treatments is voluntary and at the participant's own responsibility.

The participant remains responsible for their own physical condition and wellbeing, and that of their baby.

Participants are advised to consult their midwife or healthcare provider in case of any concerns or complaints.

L.M.J. Geboortegeluk cannot be held liable for any physical or psychological complaints resulting from participation.

6. Location and home appointments

For appointments at the client's home, no preparation is required unless otherwise agreed.

The client is responsible for providing a safe and suitable environment for the treatment.

7. Travel costs

For appointments at home, travel costs of €0.23 per kilometre apply for distances beyond a 35 km radius from Someren, calculated for the return journey.

8. Group courses and locations

Participants are expected to respect the venue, materials, and other participants.

L.M.J. Geboortegeluk cannot be held liable for loss, damage, or injury at the location, unless caused by proven negligence.

9. Materials and intellectual property

All materials provided are for personal use only.

It is not permitted to copy, distribute, or use materials for commercial purposes without written permission.



10. Privacy and media

Photos or impressions may be taken during courses for use on website or social media. Participants will not be identifiable or tagged without consent. If a participant prefers not to appear in any media, this can be communicated in advance.

11. Force majeure

In case of force majeure, including illness, restrictions, or circumstances beyond control, L.M.J. Geboortegeluk may reschedule or adapt the service.

A suitable solution will always be offered. If no suitable alternative can be agreed upon, the paid amount will be refunded.
